The Champlain Canalway Tour is presented by Adirondack Ultra Cycling, the NYS Canal Corporation and the NYS Power Authority. This ride begins and ends at the Adirondack Ultra Cycling Bike Shop, located at: 160 Broad Street in Schuylerville, NY.

Riders will head north toward Fort Edward on the west side of the Hudson River/Champlain Canal, cross over to the east side and return to Schuylerville via the Champlain Canalway Trail and the Empire State Trail.

The route is mostly flat with one long hill at the very beginning of the ride. This ride also includes about 5 miles of packed gravel trails and dirt roads, ridable with standard road bikes using 23/25/28 mm tires. Please arrive no later than 30 minutes before the start time to check in and get ready, so that we may leave on time.

Each ride uses the same route, but with a different theme. On November 7th, we will be joined by naturalist Beth Bidwell, who will meet us at two spots and share techniques that will allow us to better connect with all that nature has to offer and introduce us to tools that we can use to attract and observe birds and other wildlife; on November 14th, we will trace the events of the murder of Jane McCrea in July of 1777 and visit related sites; and on November 21st, we will stop at several sites to learn about how the canal works and the history and evaluation of its use.
